#### 1. ABOUT EOI

I-Hub Foundation for Cobotics (IHFC), Technology Innovation Hub (TIH) of Indian Institute of Technology Delhi invites online EoI (Expression of Interest) for Collaborator, Partners, Vendors and Supplier for "Robotics and Automation Specialized Equipment/Systems for Education and Training" from eligible and experienced OEM (Original Equipment Manufacturer) or OEM Authorized Dealer for co-development, supply, installation & integration and service support with warranty.

The primary objective of this EoI is to bring major players on to a common platform for collaboration, codevelopment, deliver the equipment and systems for skilling via education and training.

#### 2. OBJECTIVE

#### 5. QUALIFICATION CRITERIA

#### A. INCORPORATION

- i) PARTICIPANT (incl. all members of the consortium, if any) should be registered under the Indian Companies Act 2013.
- ii) PARTICIPANT needs to submit their certificate of incorporation.
- iii) PARTICIPANT should be in active business in a related field for at least one (1) year.
- iv) Startups recognized by DPIIT and MSMEs aligned to Atma Nirbhar Bharat are encouraged to participate.

#### **B. EXPERIENCE**

- i) PARTICIPANT should have substantial experience and expertise in the supply and commissioning of such equipment and systems.
- ii) PARTICIPANT should have a demonstratable track record of successful execution of similar projects in India. Necessary proof of the project execution needs to be submitted to establish that the company/consortium is actively contributing to the development of the Indian ecosystem of indigenous product development and research.
- iii) PARTICIPANT should describe expertise available with their organization/consortium with specific experience of related exercise as mentioned in "Scope of Work" Section.

- i) PARTICIPANT should submit technical and financial details of (up to) the **best 3 related projects** already executed.



- d. Degree of interest shown in submitting a response on various aspects defined under section scope of work.
- e. Strategic contribution potential that vendor can offer to make this project successful.
- f. Relevant budgetary assessment.

- iii. A conflict of interest is where a person who is involved in the procurement has or may be perceived to have a personal interest in ensuring that a particular PARTICIPANT is successful. Actual and potential conflicts of interest must be declared by a person involved in an EOI process.
