- 4. To introduce specific modules of entrepreneurship skills into the training
- 5. To monitor and evaluate the effectiveness of the trainings
- 6. Assessment and certification of the students after completion of program

 - d) Attendance of the student's participation in programs conducted

- 2. EOI will be further evaluated as and when submitted, based on following aspects:
 - i. Relevant technical expertise of the service provider
 - ii. Related program successfully accomplished in the past
 - iii. Degree of interest shown in submitting a response
 - iv. Strategic contribution potential that Service Provider can offer to make this program successful.
- 3. All the service providers will be asked to present their proposal
- 4. This EOI will be terminated if none of the EOI responses are found suitable
